The It Gets Better Project's online video collection and social media platforms are at the center of its global messaging and outreach to youth. Every video offers a unique perspective, but the core message in each is the same: telling LGBTQ+ youth that, whatever their circumstances, it gets better. This simple message has attracted over one million social media followers from around the world - a number that continues to grow every month.

In 2019, It Gets Better stories were viewed 7.8 million times, with a total of 11.4 million minutes watch through social outlets like YouTube

(Revenue \$) In addition to its foundation in the United States, the It Gets Better Project supports a network of 17 international affiliates Argentina, Austria, Brail, Canada, Chile, Colombia, Dominican Republic, Greece, Guatemala, India, Mexico, Paraguay, Peru, Portugal, Russia, Spain, and the United Kingdom. Each affiliate uses the power o the It Gets Better message in its own unique way to facilitate positive change for LGBTQ+ youth - while always keeping the power of storytelling font and center. Through coordinated efforts both domestically and overseas, working alongside its affiliates, the It Gets Better Project is able to bring the expertise of established organizations into regions where resources for LGBTQ+ youth are scarce.

Through this collaborative approach, the It Gets Better Project has improve the visibility of well-established organizations that provide services for LGBTQ+ youth. The process for determining compensation of the Executive Director and Key Employees includes a review, discussion and approval by the Board of Directors, who do not have a conflict of interest in with respect to the compensation agreement, and independent of the person being compensated. The Board of Directors makes compensation decisions by looking at comparability data, the skills and expertise of the executive and the performance in meeting goals and expectations.
